How to Sterilize Tools? So Many Opinions...

During our May meeting, when the question was tossed to the group "What is the best way to sterilize tools?" the responses were flying fast and furious. It seemed that no two people used the same method- "Bleach!", "Physan!", "A torch!", "Put them in the dishwasher!", "TSP!", "Buy disposable razor blades!", "Rubbing Alcohol!", "Hydrogen peroxide!". It was almost comical, and if more people were at the meeting no doubt there would have been more opinions. It seemed like it was a topic that was begging for clarification and further research. I searched the archive of *Orchids* magazine and found an excellent article by Sue Bottom in the October 2018 issue, "Orchid Hygiene". Horizontal Surfaces: Disinfect the surface regularly and keep newspaper handy to use as a temporary tablecloth and barrier to cross contamination. Be careful about placing used utensils or plant material on the surface.

Cutting Tools: Cutting tools should be sterilized between plants, and sometimes between cuts. Studies of 16 disinfectants resulted in the recommendation of only three that reliably deactivate virus particles: 2% Virkon S, 10% Clorox regular bleach solution (0.5% sodium hypochlorite) and 20% nonfat dry milk. (Li et al.) Of these three, the author has only tried the bleach solution and found it to be corrosive on tools. Instead, she uses a torch with a self-igniting trigger. With this method there is no need to wonder if your solution is strong enough or if you have left the tools in contact with the solution for long enough. So, it seems that whoever shouted "Torch!" was the



winner of this controversy. (Dave)

Reusing Pots: Plastic pots can be sterilized by dropping them into a 10% bleach solution for an hour or more. Clay pots have to be heat sterilized by baking at 400F for an hour or two. Wooden products such as baskets should be considered singleuse products.

Hands: When repotting, the author washes her hands with Lysol All Purpose Cleaner between plants.

Directions to the Grays' house for the June 09, 2024 meeting:

TO THE GRAYS' RESIDENCE FROM THE SOUTH

Take I-91 North to Exit 1. (BRATTLEBORO, VT). At the bottom of the ramp go right. Go through 5 sets of lights. After the 5th set of lights, follow signs for Route 30. The signs will lead you around a large triangular circle. After a left hand turn at one "Corner" stay in the right-hand lane. This will turn into a right-turn-only lane heading out of the circle. The road goes gently downhill through the Retreat Hospital and then opens up into Route 30. Continue on Route 30 For 8 Miles (After 6 miles you'll pass a covered bridge on the right.) Take the left turn to WILLIAMSVILLE-South NEWFANE. After 2 miles you will cross a cement arch bridge. Take a left at the end of the bridge. You are now in WILLIAMSVILLE. Go past the Fire House/General Store on the right to the post office (Red with white trim). Go right on BAKER BROOK ROAD for 1.3 miles, keeping the brook on your left. Our house is on the right and is grey with black trim. In front are signs for #260 and BAKER BROOK ORCHIDS

TO THE GRAYS' RESIDENCE FROM THE NORTH

Take I-91 South to Exit 4. At end of ramp take a left. This is Route 5. Proceed 2.3 miles. Turn right onto East/West Rd. Travel 2.0 Miles to Dummerston Center. At 4 way stop signs, continue driving straight ahead. After going 2.5 miles, you will come to a covered bridge. Cross the bridge and turn right onto Route 30. Go 1.9 miles north on Route 30. Take a left hand turn and proceed 3 miles to the TOWN OF WILLIAMSVILLE. Cross Cement Bridge and take a left-hand turn. Go 0.3 mile to BAKER BROOK ROAD on the right (across from the Post Office.) Go 1.3 Miles on BAKER BROOK ROAD, always keeping brook to your left. Our house is on the right and is grey with black trim. In front are signs for #260 and BAKER BROOK ORCHIDS.
